C.) GRAVESIDE SERVICE - \$1330.

Ceremony conducted at graveside. An evening of visitation. Includes itemized services: 1a, 2c, 2h, 3, 4b, 4c, 5a, 5b. Casket not included. (Package valid with casket purchased through Eaton Family only.)

D.) DIRECT CREMATION - \$595.

Cremation only. No ceremony. Includes itemized services: 1b, 2h, 4a, 4d, 4f, 5a. and Minimum Cremation container. (No charge for Cremation Container, when Direct Cremation package is purchased.)
